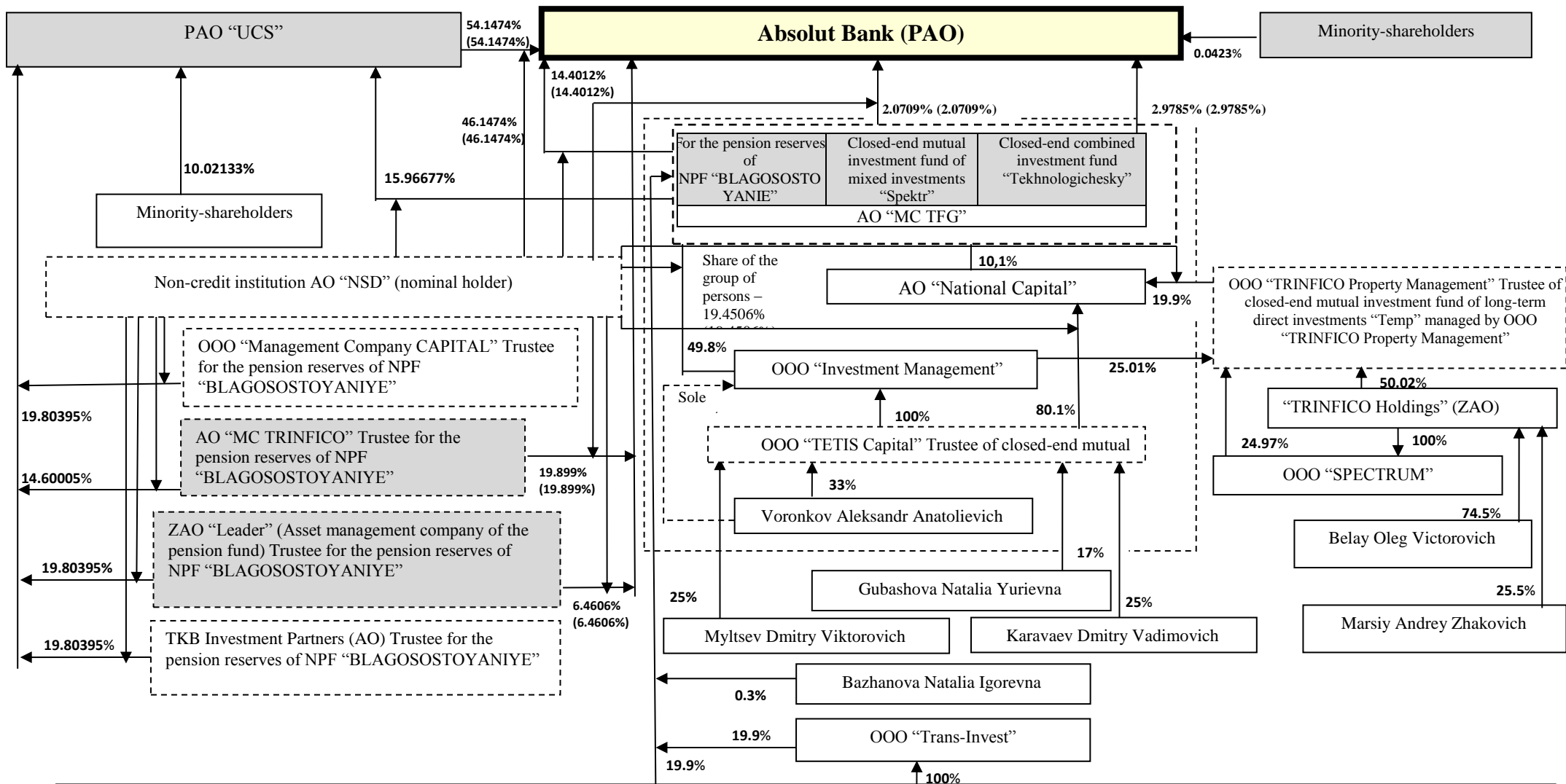

According to Para. 1 of Article 65.1 of the Civil Code of the Russian Federation, the founders of the NPF "BLAGOSOSTOYANIYE" as a unitary legal entity, are not participants to and have no membership rights in it.

The supreme management body – the Fund's Board is composed of the Fund's Executive Director (ex-officio) and the following individuals:

- From a public organization – Russian Trade Union of Railwaymen and Transport Builder – 1 (one) member of the Funds Board;
- From the Open Joint Stock Company "Russian Railways Trading House", - 3 (three) members of the Funds Board;
- From the Charity Foundation to promote the development of the railway transport "Transsoyuz" – 1 (one) member of the Funds Board;
- From the public association of railway transport industry employers – 1 (one) member of the Funds Board;

Each of the Fund's Board members has 1 vote, the voting on the items of the Foundation Board meeting's agenda is carried out without directives or other special instructions of legal entities addressed to their representatives, which does not allow significant influence of any of these legal entities over the NPF "BLAGOSOSTOYANIYE" activities.
